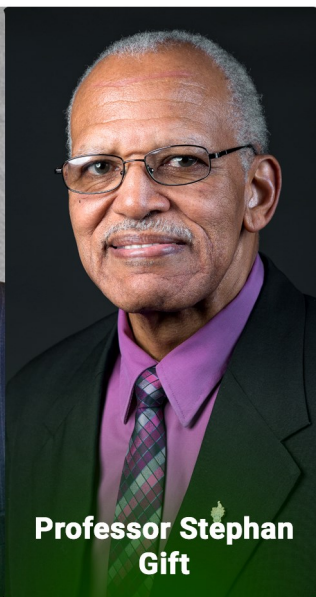

The Board approved:

:: AT THE CAVE HILL CAMPUS

DipG Renewable Energy Management

- The introduction of the Postgraduate Diploma in Renewable Energy Management, with effect from September 01, 2018.

:: AT THE MONA CAMPUS

DipG Hospitality Management

- The introduction of the Master of Science in Hospitality Management, with effect from September 01, 2019.

MSc Physical Therapy

- The modification of the Master of Science in Physical Therapy, with effect from September 01, 2018.

DM Dermatology

- The introduction of the Doctor of Medicine in Dermatology, with effect from July 01, 2019.

MPhil/PhD Sport

- The introduction of the Master of Philosophy and the Doctor of Philosophy in Sport, with effect from January 01, 2019.

:: AT THE OPEN CAMPUS

DipG/MEd/EdD Teaching & Learning with Emerging Technologies

- The amendment to several course titles in the
 - Postgraduate Diploma in Teaching & Learning with Emerging Technologies,
 - Master of Education in Teaching & Learning with Emerging Technologies with specialisations in (i) Teaching & Learning (Facilitation); (ii) Instructional Technology Support; and (iii) Curriculum Quality Support as well as the
 - Doctor of Education in Teaching & Learning with Emerging Technologies with specialisations in (i) Teaching & Learning (Facilitation); (ii) Instructional Technology; and (iii) Curriculum Technology with effect from September 01, 2018.

EdD Educational Leadership

- The amendment to the (i) programme regulations and procedures with respect to course exemptions, (ii) the replacement of the *EDRS8007 Research Processes in Education* to *Research Processes*, and (iii) the removal of two *Research Course Room* courses, the change of nomenclature of the remaining *Research Course Room* courses and a reduction of credit hours from 72 credits to 66 credits for the **Doctor of Education in Educational Leadership**, with effect from October 04, 2018.

DipG Project Management

- The introduction of the **Postgraduate Diploma in Project Management**, with effect from October 11, 2001 to enable students initially registered in the MSc Project Management programme who had not completed their research project within the prescribed time limit to be awarded the Diploma on request.

DipG/MBA International Trade, Logistics and Procurement

- The modification of the **Postgraduate Diploma and the Master of Business Administration in International Trade, Logistics and Procurement**, with effect from January 01, 2019.

- The provisions for the **Appointment and Duties of a University Examiner for The Doctor in Medicine Programmes in The Faculty of Medical Sciences**, which will be submitted to the Standing Committee for Ordinances and Regulations (SCOR) for consideration.
