Professor Lloyd Waller is a distinguished academic and thought leader at The University of the West Indies (The UWI). He specialises in Digital Transformation Policy and Governance and conducts research in a wide range of areas, including governance, digital transformation, tourism resilience, and crisis management.


Over the past decade, Professor Waller has produced a substantial body of work with more than 100 publications, including books, peer-reviewed journal articles, and technical reports. His expertise spans advanced research methodologies, particularly in qualitative, quantitative, and mixed methods research. He is widely recognised for his contributions to digital transformation, particularly in the Caribbean, where he advocates for integrating digital policies to enhance governance and public sector performance.

Professor Waller is best known for his pioneering work in the field of tourism resilience, particularly in his role at the Global Tourism Resilience and Crisis Management Centre (GTRCMC). He played a central role in the United Nations' declaration of Global Tourism Resilience Day, observed annually on February 17. This global recognition highlights the need to build resilient tourism sectors that can withstand crises such as pandemics, natural disasters, and other disruptions. His contributions have positioned both The UWI and Jamaica as global leaders in the conversation around sustainable tourism.

Professor Waller's dedication to his field has been recognised on multiple occasions. In 2023, he was awarded the Order of Distinction (Commander Class) on Jamaica's National Heroes Day for outstanding work in tourism resilience and governance. This national honour highlights his impact on the academic community, global governance, and public policy regarding tourism and crisis management.

Beyond academia, Professor Waller has taken on advisory roles, serving as a Senior Advisor to Jamaica's Minister of Tourism, Edmund Bartlett, and contributing to policy development to foster resilience in tourism. His forward-thinking approach to governance and crisis management influences regional and global strategies on how tourism industries can adapt to and recover from crises. Professor Lloyd Waller is a leading figure in the Caribbean for his innovative contributions to governance, digital transformation, and tourism resilience. His extensive research and advocacy continue to shape policies that affect global and regional responses to tourism and governance challenges.

As Director of SALISES, Mona, Professor Lloyd Waller plays a pivotal role in advancing the Institute's mission: "to shape academic, public, and policy debates by conducting research and delivering graduate education from a Caribbean perspective, within a multidisciplinary, small-state, and comparative framework." #### **Regional Forums and Workshops**

Caribbean Climate Justice Alliance and Civil Society Regional Forum, Antigua, May 23-24, 2024



Ahead of the United Nations Fourth International Small Island Developing States Conference in Antigua and Barbuda, a Caribbean Civil Society Summit was hosted, bringing together over forty civil society representatives from fourteen Caribbean states and overseas territories in Antigua and Barbuda on May 23-24, 2024. The University of the West Indies was represented by Dr. Patricia Northover, in her capacity as Principal Investigator of the Regional Disaster Capitalism project, and as a member of the Caribbean Climate Justice Alliance and the Stronger Caribbean Together Network, for food, land, and climate justice.

"The Summit offered a critical forum for shaping civil society's discourse on the new ten-year sustainable development agenda, the 'Antigua and Barbuda Agenda for SIDS' (ABAS) at SIDS4. Co-hosted by the Caribbean Natural Resources Institute (CANARI) and the Environmental Awareness Group (EAG), the Summit provided participants the opportunity to crystallise civil society's collective recommendations for sustainable development in the forthcoming decade" (Press Release CANARI: <a href="https://canari.org/civil-society-and-governance/caribbean-civil-society-unites-for-bold-action-on-sustainable-development-at-sids4-launches-collective-ten-year-plan-of-action/">https://canari.org/civil-society-and-governance/caribbean-civil-society-unites-for-bold-action-on-sustainable-development-at-sids4-launches-collective-ten-year-plan-of-action/</a>).





This workshop, hosted in Kingston, Jamaica, brought together civil society and indigenous organisations from over 10 countries in the region, legal partners from Ireland and the United States, and academic affiliates from the University of Antwerp and the National University of Colombia to explore the intersection of environmental change, economic exploitation, and community resilience, discuss the impact of disasters and disaster capitalism in the Caribbean and plan strategies for promoting climate justice. The workshop was hosted as part of the Disaster Capitalism in the Region project funded by the Open Society Foundations and led by Dr. Patricia Northover.

#### Introduction to RBM: Monitoring and Evaluation for Professionals Workshop



The "Introduction to RBM: Monitoring and Evaluation for Professionals" online workshop was conducted via Zoom in partnership with Caribbean Evaluators International (CEI) and Le Groupe-conseil Baastel and co-coordinated by Dr. Arlene Bailey and Dr. Dacia Leslie. This workshop aimed to equip administrators, project managers, and other professionals with the essential skills and knowledge to effectively implement results-based management (RBM) in their respective fields.

The event attracted diverse participants from various sectors, including non-governmental organisations, government agencies, and multilateral organisations. Among the attendees were representatives from the Jamaica Social Investment Fund (JSIF), the Culture, Health, Arts, Sports & Education (CHASE) Fund, the Caribbean Community (CARICOM) Implementation Agency for Crime and Security, the Ministry of Health, and the Development Bank of Jamaica.

Dr. Patricia Northover, the then Acting Director of SALISES, Mona, formally launched the work-

shop with opening remarks, emphasising the importance of capacity building in monitoring and evaluation practices to strengthen the effectiveness of initiatives across the region.



#### Sir Arthur Lewis Distinguished Lecture







#### Sir Arthur Lewis Day 2024 – Keynote Lecture

"Economic Dualism, Employment and Development in the Era of Climate Change"

Small dualistic economies that still face the development challenge are now threatened by climate change. What are the constraints to coping with these multiple challenges, and how can they be overcome?

**Professor Jayati Ghosh**

Jayati Ghosh taught economics at Jawaharlal Nehru thored and/or edited 20 books and more than 200 scholarly articles. She has received several prizes, including the 2023 John Kenneth Galbraith award by the Agricultural and Applied Economics Association, "in recognition of breakthrough discoveries in economics and outstanding contributions to humanity through leadership, research and service." Prof. Ghosh has advised governments in India and other countries, including as Chairperson of the Andhra Pradesh Commission on Farmers' Welfare (2004), and Member of the National Knowledge Commission of India (2005-09). In March 2022, she was appointed to the UN Secretary General's High-Level Advisory Board on Effective Multilateralism, mandated to provide a vision for international cooperation to deal with current and future challenges.



Professor Jayati Ghosh delivered the Sir Arthur Lewis Distinguished Lecture (January 23, 2024) on the topic "Economic Dualism, Employment, and Development in the Era of Climate Change", addressing the intricate interplay between economic dualism and the broader challenges of employment and development within the context of a rapidly changing climate. Economic dualism, characterised by the coexistence of modern and traditional economic sectors, often entrenches inequalities, particularly in developing countries. This dualism manifests in segmented labour markets, widespread informal employment, and limited access to decent work, thus impeding comprehensive economic development.

Professor Ghosh highlighted how climate change compounds these challenges by disproportionately affecting vulnerable populations and sectors, especially those dependent on agriculture and other climate-sensitive industries. The adverse impacts of climate change, such as extreme weather events, shifts in agricultural productivity, and resource scarcity, exacerbate existing economic disparities, further entrenching the divide between modern and traditional sectors.

The lecture highlighted the necessity of a comprehensive approach to development that integrates climate resilience into economic frameworks. Professor Ghosh advocated for robust public policy interventions to foster inclusive growth, sustainable job creation, and equitable resource distribution. She emphasised the importance of strategic investments in green technologies and infrastructure that drive economic development and enhance environmental sustainability.

A critical component of her argument was the need for enhanced global cooperation to address climate change, mainly through mechanisms that support developing nations, such as technology transfer, financial assistance, and capacity building. Professor Ghosh stressed that efforts to reduce economic inequalities and achieve sustainable development would be severely constrained without substantive international support.

Professor Ghosh called for urgent policy reorientation to align economic strategies with environmental imperatives. She argued that the future of development in the climate change era hinges on reconciling economic growth with environmental stewardship and social equity principles. Her presentation illuminated the pressing need for transformative economic paradigms that prioritise sustainability and inclusivity as foundational elements of development strategies.

#### **SALISES 25th Annual Conference**

The 25th Annual Conference of the Sir Arthur Lewis Institute of Social and Economic Studies (SALISES) at The University of the West Indies (The UWI) was a notable event, held May 1–3, 2024, at The UWI Regional Headquarters. This year's conference, themed "Translating Thought into Action: Towards Decolonial Equity and Justice in the Caribbean", brought together a diverse group of participants, including students, scholars, representatives from NGOs,

civil society organisations, and major international bodies from Jamaica, the wider Caribbean, North America, Europe, and Mexico. The conference served as a platform for in-depth discussions on pressing issues and potential solutions related to sustainable development.

The event was inaugurated with an opening ceremony featuring Dr. Peter Phillips as the guest speaker. Drawing on his extensive experience as a scholar and a public servant, Dr. Phillips highlighted Jamaica's progress over the years while also underscoring the ongoing challenges, particularly the need for a national consensus on key economic and social development aspects. A significant moment during the ceremony was the signing of two memorandums of understanding (MOU) between SALISES and the Institute of

Development Studies (IDS) at the University of Sussex, reinforcing their collaborative efforts and established a new seven-year partnership with Universität Kassel in Germany, starting on December 19, 2023.

Throughout the conference, numerous breakout sessions addressed a range of topics such as decolonializing knowledge for development (DK4D), reparatory justice, the coloniality of gender, regional security, children's rights, food equity, justice and security, tourism, climate and energy, decolonizing states, crime and law, and postcolonial growth options. Two plenary sessions further delved into the central conference theme. The opening plenary on Reparations for Epistemic and Colonial Violence was co-hosted with the Center for Reparations Research. The active participation of international partners, including UNDP, UNICEF, the Caribbean Policy Consortium (CPC), and the MiFood Network, brought heightened global attention to the issues discussed, underscoring the role of SALISES and The UWI in shaping regional policy and practice.

Dr. Holger Henke, the then Director of SALISES (Mona), emphasised the Institute's commitment to being the leading research institution in the English-speaking Caribbean, dedicated to critically assessing and offering pragmatic advice on sustainable development challenges. This sentiment was echoed by Kishan Khoday, UNDP's representative in Jamaica, who questioned whether development policies should continue as usual amid growing systemic risks or if there was a need to challenge existing paradigms.

The final day of the conference featured the recognition of a significant donation—the private library of the late Professor Ambassador Richard Bernal, honoured with a certificate presented to his wife, Margaret Bernal. Additionally, SALISES launched a fundraising initiative for the future "Richard L. Bernal Reading Room and Commons". This envisioned space within SALISES will be a versatile, multi-purpose facility equipped with modern technology to support meetings, teaching, creative projects, and community outreach.

Overall, the 25th Annual SALISES Conference successfully highlighted the Institute's critical role in advancing dialogue and action on decolonial equity and justice in the Caribbean, bringing together diverse voices to explore pathways towards sustainable development.

#### **International Partnerships**

At the 25th Annual Conference of the Sir Arthur Lewis Institute of Social and Economic Studies (SALISES), a significant milestone was marked with the signing of two Memoranda of Understanding (MOUs). SALISES renewed its collaborative efforts with the Institute of Development Studies (IDS) at the University of Sussex, formalising a new three-year agreement commencing on May 1, 2024. This agreement builds upon the institutions' longstanding partnership and aims to continue their joint initiatives in research and development. Additionally, SALISES established a new seven-year partnership with Universität Kassel in Germany, starting on December 19, 2023. These MOUs reflect SALISES's commitment to fostering international collaboration and enhancing research capacity to address critical social and economic challenges in the Caribbean and beyond.



Joint Launch of the Law and Economics Discussion Series at The University of the West Indies, Mona Campus

The Faculty of Law, Department of Government, and the Sir Arthur Lewis Institute of Social and Economic Studies (SALISES) at The University of the West Indies (UWI), Mona Campus, in collaboration with the Institute of Law and Economics (ILE), jointly launched a new discussion series focused on exploring issues arising from the intersection of law and economics. This collaborative series will address pressing governance and constitutional challenges in the Caribbean, framed by current global, regional, and local crises that intensify human insecurity and widen the gap between development goals and the lived realities of Caribbean citizens.

The inaugural event took place on December 12, 2023, under the theme "Republic – A Public Matter: Legal and Economic Perspectives for Constitutional Change in Jamaica." The event examined Jamaica's road to become a Republic, which is taking place under the aegis of the recently established Ministry of Legal and Constitutional Affairs and the Constitutional Reform Committee, that have been given the mandate to lead and guide constitutional change for the nation. Prof. Rosalea Hamilton, founder of the ILE, was the featured speaker with Prof. Vanus James, an economist and consultant, acting as the discussant. The event was moderated by Dr. Leslie Kelly, from the Department of Government, creating a space for vibrant dialogue around the economic and legal implications of constitutional reform in Jamaica.

The concept for this launch was based on a project application for a UNESCO- UNOHCHR, Chair for a Human Rights Economy that was led by Dr. Ramona Biholar and Dr. Patricia Northover in September 2023. This initiative represents a significant step toward fostering critical discussions on constitutional change and development in the Caribbean, inviting varied perspectives from experts in politics, law, and economics. Through these sessions, UWI Mona, in collaboration with its partners, aims to provide a platform that encourages inclusive, well-informed dialogues essential for advancing the full decolonization of the State and a transformational rights based socioeconomic and political governance in the Caribbean.



## SALISES Engages in Historic Inter-American Court of Human Rights Hearing on Climate Emergency

On April 23, 2024, Dr. Natalie Dietrich Jones, Research Fellow at the Sir Arthur Lewis Institute of Social and Economic Studies (SALISES), participated in a landmark Public Hearing of the Inter-American Court of Human Rights (IACtHR). The hearing at the Business School of the Cave Hill Campus from April 23 to 25, 2024, addressed the request for Advisory Opinion OC-32, "Climate Emergency and Human Rights", submitted by Colombia and Chile.

Dr. Dietrich Jones's involvement represents the culmination of collaborative work initiated in 2023, during which she contributed to a Working Group focusing on internal and cross-border displacement linked to climate change. This group, comprising academics and activists from institutions including the Center for Gender and Refugee Studies (CGRS), the International Refugee Assistance Project (IRAP), and the Global Center for Legal Environmental Studies (GCELS) at Pace University's Elisabeth Haub School of Law, among others, submitted an amicus curiae to the IAC-tHR in December 2023.

Dr. Dietrich Jones, Camila Bustos (GCELS), Felipe Navarro Lux (CGRS), and Jose Miranda (IRAP) represented the delegation at the Court. The delegation's presentation was part of a satellite project funded and technically supported by IRAP to develop a Legal Action Agenda on Climate Displacement in the Americas. At the hearing, Dr. Dietrich Jones called on the Court to consider "the distinctive human rights settings which shape the jurisdictions which will receive the opinion, in particular, Small Island Developing States (SIDS)."

The delegation's contribution followed an earlier session led by the Cave Hill Faculty of Law, the One Ocean Hub, and other collaborators, which focused on the law of the sea. The Court is reviewing the submissions and will issue its advisory opinion based on the input received.

#### Dr. Dacia Leslie Advocates for CARICOM MEAL Framework in Corrections Reform

Dr. Dacia Leslie, Senior Research Fellow at the Sir Arthur Lewis Institute of Social and Economic Studies (SALISES), called for a coordinated CARICOM Monitoring, Evaluation, Accountability, and Learning (MEAL) framework during her address at the regional dialogue event for the Caribbean Corrections Roadmap Initiative on July 15, 2024. The event, which focused on enhancing corrections reforms to address overcrowding and recidivism in the Caribbean, marked the launch of the 2024 Caribbean Corrections Data Survey.

The initiative, supported by Georgetown University and the U.S. Department of State's Bureau of International Narcotics and Law Enforcement Affairs, aims to implement effective correctional systems across CARICOM States. Dr. Leslie emphasised the need for improved correctional data infrastructure to support evidence-based decision-making and enhance the efficiency of correctional services.

The dialogue brought together experts from the corrections sector, donor representatives, and officials to discuss strategies for mitigating challenges within the Caribbean correctional systems. Dr. Leslie highlighted the critical role of capacity development training provided by The UWI and urged partners to focus on strengthening MEAL systems to foster a learning environment that informs future correction strategies.

The discussions and insights from this event informed the 12th Annual Conference of The Association of Caribbean Heads of Corrections and Prison Services in The Bahamas, held on September 9–12, 2024, under the theme "From Theory to Reality: Shaping the Future of Corrections and Prisons in the Caribbean".

Several members of the organisation were instrumental in supporting the launch of the professional development workshop titled "Introduction to RBM: Monitoring and Evaluation for Professionals" in June 2024. Mrs. Valerie Gordon, President/ Chair of the Board of Directors, CEI, spearheaded the mobilisation efforts for the workshop, and Richard Leach, SALISES Mona, provided IT support.

The 18th Annual Child Research Conference was hosted on November 29–30, 2023, by the School for Graduate Studies and Research, The University of the West Indies (The UWI) in partnership with the Sir Arthur Lewis Institute of Social and Economic Studies, Government of Antigua and Barbuda and the United Nations Children's Fund. The conference was held under the theme, "A Safer Planet for Every Child: Striving for a World Where Children's Rights are Respected and their Voices Heard", at the Five Islands Campus of The UWI in Antigua and Barbuda. This was the first time the conference was hosted outside

of Jamaica, with 29 research paper submissions from across the Caribbean region.

Ms. Abigay Dunkley from William Knibb Memorial High School located in Trelawny, Jamaica, came out as a top researcher, and was also the recipient of the Mayeltha and Gwendolyn Scholarship of J\$100,000. The annual scholarship is open to the top ten child researchers (below 18 years of age) who are Caribbean nationals living in difficult circumstances.

Children living in difficult circumstances face a myriad of challenges, but the protective role that emotional and moral support as well as mentorship plays to help lift them from where they are to a better future should not be underestimated. For Abigay Dunkley, this support came from her guardians – brother, Damion Forbes, and sister, Simone Forbes – and her Guidance Counsellor at school. Always remember that if we can each play a positive role in the life of a child/children living in difficult circumstances, we contribute to addressing their protective needs and help them counter the many risks they face on a daily basis.

#### SOCIAL AND ECONOMIC STUDIES, VOL. 72, NOS. 1&2 (2023) REPUBLICANISM IN THE COMMONWEALTH CARIBBEAN




As the issue of republicanism regains traction in the Commonwealth Caribbean after a hiatus of forty-three years between the termination of the associated statehood of Dominica in 1978 and the termination of the monarchical status of Barbados in 2021, this special issue, guest-edited by Hamid Ghany, is dedicated to the topic of Republicanism in the Commonwealth Caribbean.

Of the twelve independent countries of the Commonwealth Caribbean, there are four republics: Guyana (1970), Trinidad and Tobago (1976), Dominica (1978), and Barbados (2021). In many respects, there was a lull in the movement for republicanism between the 1970s and the present day. Will republicanism regain its momentum in the Commonwealth Caribbean in the aftermath of Barbados or is there more political talk than action?

The collection of articles in this special issue highlights some key areas of the republican movement in the Commonwealth Caribbean: from quasi-ceremonial presidencies to hybrid presidentialparliamentary republicanism, the movement to republicanism in Barbados, an analysis of the constitutional moment that the transition to republicanism in Barbados has presented to the Commonwealth Caribbean, and an examination of the exercise of presidential powers after the replacement of the Governor General.

Republicanism has some distance to travel as it must surmount parliamentary divisions and public consciousness issues across the region in those eight countries that are yet to become republics.



This special issue delves into these questions and provides a useful analysis of the road travelled and the challenges ahead.

#### Thelma White (Librarian III) Citation

Thelma White has had a notable career at The University of the West Indies (The UWI), where she worked for 18 years, 14 of which were richly shared with us at the Sir Arthur Lewis Institute of Social and Economic Studies. Thelma's career at The UWI began in 2006 at the West Indies and Special Collections of the University Main Library, where she played a pivotal part in the growth and maintenance of the West Indian database. Her work involved indexing thousands of records, significantly expanding the database, and enhancing access to West Indian resources. Thelma's meticulous cataloguing and classification of documents, done with exceptional care and attention to detail, provided reference services that made the collection more accessible to researchers and the general public. Her contributions to various exhibitions, through research and the provision of materials with West Indian content, were instrumental in preserving and showcasing the region's rich heritage.

After her tenure at the UWI Main Library, Thelma transitioned to SALISES in 2010, where she continued to make significant contributions. As a Librarian at the Documentation Centre, she managed the internal database, ensuring its growth and standardisation. Her responsibilities included supervising the abstraction and indexing of articles from journals and conference papers, which led to the expansion of critical bibliographic databases. Thelma's role in this expansion significantly enhanced the research environment. She also oversaw the creation of a collection that documented SALISES's 50/50 series of events, which included papers, photographs, and multimedia resources. She was deeply involved in organising and archiving these materials, ensuring their preservation for future generations.

In addition to her technical skills, Thelma assisted with staff supervision and guiding students in research and citation methods. Her ability to conceptualise and prepare regular displays highlighted her creative approach to library services. Throughout her career at SALISES, Thelma was known for her dedication to enhancing the research environment and her unwavering commitment to the preservation of Caribbean knowledge and culture, a commitment that inspired those around her. Thelma was also a member of the SALISES Crime Prevention and Offender Management Research Cluster, led by Dr. Dacia Leslie, Senior Research Fellow, where she contributed to the vibrant research life of our Institute. She has published nine articles, further cementing her role as a significant contributor to Caribbean research.

Thelma is a fun-loving and animated individual who can bring life and laughter wherever she goes. Her quick wit and infectious sense of humour make her the heart of any gathering. Always ready with a joke or a light-hearted comment that never fails to lift the spirits of those around her, Thelma's lively and energetic nature is complemented by her deep commitment to her faith, which is central to her life. She attends church services with unwavering regularity, finding strength and solace in her religious practices.

In her professional life, Thelma is equally dedicated and passionate. Her enthusiasm for her work is palpable, and it has earned her the respect and admiration of her colleagues. Whether tackling a challenging project or mentoring a junior staff member, Thelma approaches every task with the same vigour and positivity that defines her personality. Her ability to balance her work with her deep-rooted faith and active community involvement is truly inspiring. This unique blend of humour, dedication, and faith makes Thelma a cherished colleague and a beloved friend to many. Her presence is a source of joy, comfort, and inspiration, making her an indispensable part of any circle she is a part of, professionally and personally.

#### Dr. Khadijah Williams: JAS Phenomenal Woman Awardee







Dr. Khadijah Williams, Honorary Consultant at the Sir Arthur Lewis Institute of Social and Economic Studies (SALISES), The University of the West Indies (The UWI), Mona, has been honoured with the Jamaica Agricultural Society's Phenomenal Women in Agriculture 2024 Award. Dr. Williams was selected among 19 influential women for her exceptional contributions to agriculture and rural development in Jamaica.

With a career spanning over three decades, Dr. Williams has combined her expertise in social work, psychology, and human resource management with a hands-on approach to agriculture. Trained at The UWI, St. Augustine, and Lancaster University in the UK, she has taught courses on rural social work and community development across The UWI St. Augustine and Mona campuses and currently serves as a Visiting Professor at the University of Guyana.

Dr. Williams is a prominent figure in rural development, serving as Chairperson of the Education, Research, and Policy Committee for the Jamaica Network of Rural Women Producers and as a Board Member for the Rural Agricultural Development Authority (RADA) in St. Ann, Jamaica. Her influence extends beyond Jamaica, with her work resonating across the Caribbean, the USA, and the UK.

She has pioneered the use of agriculture as a tool for behaviour change and mental health promotion, focusing on the production of indigenous foods to prevent conditions such as dementia and depression. Her commitment to food security and sovereignty is reflected in her active community outreach, educating local farmers through seminars. Dr. Williams also co-founded Village Academy International, a residential post-secondary school for marginalised

youth, which supports young people transitioning from state care and those facing educational challenges, preparing them for careers in agriculture.

A leader in Afro-Caribbean integration, Dr. Williams' work promotes collaboration and the preservation of indigenous knowledge. She co-led the first International Black Youth Food Sovereignty Forum in 2022, connecting youth from the Caribbean, North America, and Africa to discuss sustainable food systems. Dr. Williams' dedication to agriculture, mental health, and youth development has established her as a thought leader and a true champion for rural communities in the Caribbean and beyond.

#### Passing of Professor Patricia Anderson, CD

SALISES deeply mourns the loss of our esteemed former colleague, Professor Patricia Anderson, CD, who passed away on Sunday, October 13, 2024. Professor Anderson began her distinguished career at The University of the West Indies, Mona Campus, in 1982 as a Research Fellow at the Institute of Social and Economic Research (ISER), now SALISES. Her dedication and expertise led her to advance to the positions of Senior Research Fellow and Deputy Head, before joining the Department of Sociology and Social Work in September 1992 as a Senior Lecturer. She served as Head of the Department from 2000 to 2003, leaving an indelible mark through her exemplary leadership.

In 2007, Professor Anderson was honoured with the National Order of Distinction, Commander Class, in recognition of her significant research contributions to public policy development. She retired in 2010, concluding an illustrious career as a scholar, teacher, mentor, administrator, and social policy specialist. Her

legacy of dedication and service to academia and public policy will continue to inspire those who had the privilege of knowing her. She will be fondly remembered and deeply missed by the entire UWI community.
