# Stacy Richards-Kennedy DIRECTOR, OFFICE OF DEVELOPMENT

As the focus of the global development agenda shifted from the Millennium Development Goals (MDGs) to the Sustainable Development Goals (SDGs) in 2015, national and regional development actors in the Caribbean began aligning their efforts to support the United Nations 2030 Agenda for Sustainable Development. This ambitious, inter-sectoral development programme established 17 global goals covering a broad range of social and economic development issues including poverty, health, education, climate change, gender equality, water, sanitation, energy, urbanization, environment and social justice. Universities play a central role in helping to advance the 2030 development agenda, by driving research and innovation as well as providing relevant education, training and public service. The UN-Sustainable Development Solutions Network has underscored the need to ensure greater alignment between universities and development actors to support the localization and achievement of the global goals.

At the UWI, the Office of Development established in September 2016, is focused on strengthening the partnerships between the University and multilateral development agencies and deepening the university's engagement with regional and national development processes. This is consistent with the Outreach perspective of the UWI Strategic Plan 2012-2017, which promotes the university as driving force for economic, social, educational and other critical development needs of the region.

During the period 2016-2017, the Office of Development led a range of initiatives, at both the strategic and operational levels, that served to strengthen UWI's positioning and advocacy on the 2030 development agenda, promote mechanisms for multidisciplinary research collaborations, knowledge brokerage and stakeholder engagement linked to the SDGs, establish key institutional partnerships with multilateral development agencies, support fundraising efforts for strategic initiatives and contribute to the implementation of Balanced Scorecard monitoring and reporting for the new UWI Strategic Plan 2017-2022 led by the Office of Planning.
